OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

All federal, state and local regulations apply.

1. DATES.

These rules govern the 2018 Sun Powersports ATV Giveaway (the “Contest”) being conducted by KYGO-FM (the “Station”). The Contest will begin at 12:00am Mountain Time (“MT”) on April 3, 2018 and will end on September 15, 2018 at 12:00pm MT.

2. ELIGIBILITY

- a. The Contest is open to all legal U.S. residents (natural persons only) who are 18 years of age or older and who reside in the Denver Metropolitan area (Counties include: Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, Jefferson, Gilpin, Clear Creek, Park and Elbert), except as noted below. Persons ineligible to win include those who do not reside in any of the counties listed above as well as employees, officers, directors, and agents of the Station, the Station’s licensee, Bonneville International, dba Bonneville Denver, KYGO, Sun Enterprises, their parent, subsidiary, and affiliated companies, their advertising or promotional agencies, and any other participating sponsors (collectively, “Promotion Entities”), employees or other persons associated with other radio stations in the Denver Metropolitan area, and the members of their immediate families and those living in the same household of each (whether related or not) of any of those listed above. “Immediate family” members include spouses, children, step-children, parents, step-parents, siblings and step-siblings. No groups, clubs, or organizations of any kind may participate in this Contest. This Contest is subject to all applicable federal, state and local laws and regulations and is void where prohibited or restricted by law.
- b. Proof of age, identity and eligibility must be furnished to Station upon request. All entry information must be complete and accurate. The Station will not award a prize to anyone not meeting eligibility requirements at the time of entry.
- c. Entrants are required to provide truthful information, and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entry from individuals who do not meet the eligibility requirements and will also delete any entry as required by law.

3. HOW TO ENTER

- a. To participate in the Contest, visit www.kygo.com and follow the links and instructions to enter the Contest and submit your first name and last name, zip code, telephone

number, date of birth, gender and a valid email address. Only one (1) entry per person is permitted. An entrant may use only one (1) email address for purposes of entry in this Contest. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address, and all multiple entries from the same email address shall be disqualified. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Station. Online entry webpage computer is the official time keeping device for the Contest. The Station is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties and other technological problems.

- b. Entries must be received between April 3, 2018 at 12:00am MT and September 3, 2018 at 11:59pm MT (“Entry Period”). Entries submitted outside the Entry Period will be deemed ineligible. Winners may be required to provide valid government-issued photo identification and provide their complete address, date of birth and phone number to claim a prize.

4. PRIZE(S)

- a. There will be One (1) Grand Prize Winner of the Contest. The Grand Prize consists of one (1) 2018 CanAm Outlander 570 DPS ATV and a helmet signed by Brantley Gilbert. Approximate Retail Value (ARV) of the Grand Prize is valued at \$8,109.99.
- b. Winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize.
- c. No more than the advertised number of prizes shall be awarded. The prize is subject to certain terms and conditions as specified herein. A prize may not be sold, traded, or commissioned, and is not exchangeable, transferable, substitutable, or redeemable for cash except in Company's sole discretion. Prize details and availability are subject to change. Prizing may be fulfilled by a third party fulfillment company. The prize will only be awarded if properly claimed according to the Rules. All costs and expenses related to the prize acceptance, the prize, and/or prize use not specified herein as being provided, are the sole responsibility of winner(s).

5. WINNER SELECTION, NOTIFICATION AND CLAIM

- a. Decisions of the Station management with respect to the Contest are final.
- b. Two-hundred (200) Grand Prize Qualifiers will be selected on September 4, 2018 at 9:00am MT. These Grand Prize Qualifiers will be contacted by the Station and invited to attend the Grand Prize drawing event to be held on September 15, 2018 beginning at 11:00am MT at Sun Powersports located at 8877 Washington Street, Thornton, CO 80229.
- c. All Grand Prize Qualifiers will be required to appear for check-in at the Grand Prize drawing event at Sun Powersports by 11:00am MT on Saturday, September 15, 2018.
- d. Each Grand Prize Qualifier will randomly select a sealed envelope with a key inside. Each envelope will be numbered and that will determine the order that the Grand Prize Qualifiers will attempt to open the lock box starting with number one

- (1). Only one (1) key will open the lock box. The Grand Prize Qualifier that successfully opens the lock box with their key will be deemed the winner.
 - e. In the event that another key should manage to open the lock box, the first person to unlock the box will be deemed the winner.
 - a. Odds of becoming a Grand Prize Qualifier depend upon the number of valid entries received. Odds of a Grand Prize Qualifier winning the grand prize depend on the number of Grand Prize Qualifiers that are present for the Grand Prize drawing.
 - f. The final winner will be selected at approximately 12:00pm MT at the Grand Prize drawing event at Sun Powersports on Saturday, September 15, 2018.
 - b. Grand Prize Qualifiers must be present at the Grand Prize event in order to win.
 - c. The winner must execute and return complete any required affidavit of eligibility and/or liability/publicity release within two (2) weeks of winning or prize will be forfeited. If a potential winner fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, the potential winner forfeits the prize and an alternate winner will not be selected. Unless otherwise permitted by the Station, winner(s) must claim his or her prize in person, and a prize cannot be claimed by third parties on behalf of the winner. A parent or legal guardian must accompany any minor children in all Promotion-related activities, and a parent or legal guardian must claim the prize and sign any requisite releases on behalf of the minor child.

Entrants and participants are responsible for complying with all applicable federal, state, and local laws and regulations and with these Contest Rules, and by entering, participants agree to be bound to these official rules. The laws of the State or Commonwealth in which the Station is licensed shall govern this Contest, without regard to that jurisdiction's choice of law rules.
 - b. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by the Station (or any other commonly owned stations in the Station's market) in a calendar year with an aggregate value of \$600 or more. Failure to submit a completed Form W-9 or equivalent upon request will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
 - c. By entering the Contest, entrants and participants grant to the Contest Entities the right to publicize the participant's name, photograph, video, image, likeness, voice, statements, hometown (city and state), and biographical information for advertising, trade, and Contest purposes in any media now or hereafter known worldwide in perpetuity without compensation and without opportunity for review, except where prohibited by law. The Station, in its sole discretion, may require each winner (and guest, if applicable) to sign a publicity release confirming such consent prior to acceptance of the prize, except where prohibited by law.

 - g. The Station, in its sole discretion, reserves the right to disqualify any person not abiding by the official rules, or for tampering with the entry process or the operation of the Station's website. Failure to comply with the rules of the Contest may result in an entrant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good faith determination that an entrant has entered more than once, or otherwise cheated or committed fraudulent activity in connection with a Contest, the Station reserves the right to disqualify that entrant from entering and/or winning future Contests and to prosecute and seek damages to the fullest extent permitted by law.

Contest Entities make no warranty, guarantee, or representation of any kind concerning any prize, and CONTEST ENTITIES SPECIFICALLY DISCLAIM ANY IMPLIED WARRANTY OF MERCHANTABILITY, WARRANTY OF FITNESS, AND ANY OTHER IMPLIED WARRANTY, except for any express manufacturer's warranty as may be included with the prize or as may be separately provided to participants by law.
