

Oil Changes for a Year Giveaway
OFFICIAL RULES AND LEGAL DISCLAIMER

1. By entering, attempting to enter, or in any way participating or attempting to participate in Oil Changes for a Year Giveaway (the “Sweepstakes”), the participant (“Participant”) agrees to be bound by these Official Rules and Legal Disclaimer and the decisions of Bonneville International Corporation (“Administrator”) relating to the Sweepstakes, which are final and binding in all respects.

2. The Sweepstakes is put on by 98.5 KYGO-FM (the “Station”).

3. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

4. **HOW TO ENTER:** Beginning on October 17, 2025, at 12:00 a.m. Mountain through October 26, 2025, at 11:59 p.m. Mountain, log on to www.kygo.com/contests and click on the icon for Oil Changes for a Year and follow the on-screen entry instructions. Fill in all required information. No more than one entry per person or email address is permitted. Use of multiple email addresses or identities or of any robotic, automatic, or programmed entry method will result in disqualification.
