

**WARREN ZEIDERS Q&A VIP EXPERIENCE  
OFFICIAL RULES AND LEGAL DISCLAIMER**

1. By entering, attempting to enter, or in any way participating or attempting to participate in Warren Zeiders Q+A VIP Experience (the “Sweepstakes”), the participant (“Participant”) agrees to be bound by these Official Rules and Legal Disclaimer and the decisions of Bonneville International Corporation (“Administrator”) relating to the Sweepstakes, which are final and binding in all respects.

2. The Sweepstakes is put on by 98.5 KYGO FM (the “Station”).

3. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

4. **HOW TO ENTER:** Listen to the Station beginning on March 2, 2026, and ending on March 6, 2026. On weekdays at around 8:00a.m., 12:00p.m., 4:00p.m. Mountain, the on-air personality will announce the cue to call the Station’s contest line of (303) 713-0985 and designate by ordinal number (e.g., 9<sup>th</sup>) the potential qualified caller. Participant must be the designated caller and provide Participant’s (a) legal name, (b) mailing address, (c) phone number, and (d) date of birth before the call is disconnected. A post office box is not acceptable. If Participant does not provide the required information before the call is disconnected or is found to be ineligible, Administrator may select the next consecutive caller as the potential qualified caller for that playtime. Upon confirmation of eligibility, Participant will be entered into the drawing for the grand prize and win a daily prize.

Online listeners to streamed broadcasts may experience a lag in transmission due to buffering limitations and other factors. Listeners to streamed broadcasts may not be able to participate in, or may be disadvantaged in participating in, the Sweepstakes.

A potential winner must also provide valid, government-issued photo identification. If, in Administrator's opinion, there is such an error, or there is any suspected evidence of tampering with any portion of the Sweepstakes, or if technical difficulties (including viruses and bugs) compromise the integrity of the Sweepstakes, Administrator, in its sole discretion, may cancel or modify the Sweepstakes in a manner deemed appropriate by Administrator.
