

KENNY CHESNEY TEXT CONTEST
OFFICIAL RULES AND LEGAL DISCLAIMER

1. By entering, attempting to enter, or in any way participating or attempting to participate in Kenny Chesney Text Contest (the “Sweepstakes”), the participant (“Participant”) agrees to be bound by these Official Rules and Legal Disclaimer and the decisions of Bonneville International Corporation (“Administrator”) relating to the Sweepstakes, which are final and binding in all respects.

2. The Sweepstakes is put on by KYGO-FM (the “Station”).

3. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

4. **HOW TO ENTER:** Beginning on September 15, 2026, at 7:00 a.m. Mountain through September 18, 2026, at 7:00 p.m. Mountain, send a text to 303-713-0985 and comply with the entry instructions. Fill in all required information. No more than one entry per person or phone number is permitted. Use of multiple phone numbers or identities or of any robotic, automatic, or programmed entry method will result in disqualification.

Each text message, sent or received, may incur a charge as provided in Participant’s rate plan. Message and data rates apply. When Participant enters via text message, Participant will receive at least one autodialed text message in response to Participant’s entry and may receive additional autodialed text messages if Participant is a finalist, qualifier, or winner, as the case may be.
